the diagram has shown the location of the 2 trees of this application.

The rear tree is located between the rear building and the rear wall. Likely when this was planted it did not cause a problem but the trunk is now 45-60 cms thick and grows in a small gap of around 3 metres, and is therefore is far too close to the building where it brushes against the walls, over the guttering and roof; the roots will be impacting upon the building foundations. The branches interfere with the telegraph cables on the road which is a high risk since a broken /overgrowing branch would cause considerable remedial cost to the householder in compensation to (BT) British Telecom.

The tree has been much taller than it is today as the top of the trunk is actually a flattish stump, so it is clear this has been reduced in height at some stage in years gone by (probably it has been causing similar problems as referenced above). This needs removal.

The second tree is in the front garden (poplar), adjacent to the front boundary and the neighboring wall. This tree became diseased this spring and died off over the summer. It sadly needs removal.

There are 2 other trees in the front garden of considerable size and the sad loss of the diseased tree will not have a materially different visual impact.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
