Pruning of trees at The Grange, 46 Burley Road, Langham, LE15 7HY	
1) Lime Trees - Raise crown of three limes trees within yard. A balanced crown raise by approximately 1m of the lower branches of three Limes Trees (1, 2, 3), situated in the yard alongside Garden Wall and entrance to property, to clear wall and allow access for good vehicles to driveway. Currently there is a lot of overhang from lower branches obstructing the driveway. Total height from ground will be approximately 5m.	
2) Yew Tree - Reshape overgrown Yew Tree (4). Pruning of tree to include crown reduction of approximately 1m and crown lift of 1m from ground. Branches to be reduced by 1m. This is to prevent the tree from suffocating the neighbouring apple tree and shrub and allowing more	

These trees were last pruned in November 2020. We would like to be able to keep them well maintained hence submitting this application.

3) Holly Tree - Reshape Holly Tree (5). Pruning of tree to include crown reduction of approximately 1m. Branches to be reduced as they are

currently obstructing the pavement on the roadside.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
