The cherry tree T1 on the front border by our drive is old and diseased and several limbs have already fallen and others are likely to fall. For safety we want to remove it and replace with another tree (variety to be agreed with planning).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
