We would like to reduce the height by 5 metres from 13 metres leaving a finished height of 8 metres.

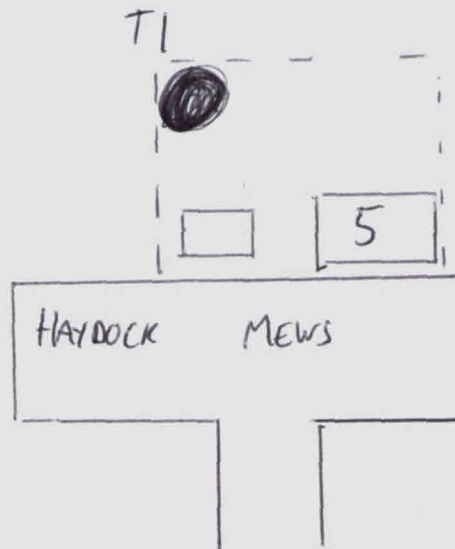
We would like to reduce the width of the tree from 9 metres by 3 metres leaving a finish of 6 metres.

Both neighbouring Oaks have had fungal issues around the base and this tree was showing similar if slightly less issues.

One tree fell over and the other was pollarded for safety.

These works are intended to retain the tree but heavily reduce its size.
