Identification of Tree(s) and Description of Works

(T1) Oak - Tree is growing in a wooded area adjacent to the drive of Camerton and overhanging Fieldside Cottages. The tree has approximately a 10 degree lean due to growing on the edge of woodland. The crown is one-sided and limbs are becoming overextended. It is also casting significant shade over Fieldside Cottages when in full leaf. Proposing to reduce left hand side of tree by up to 2m in order to balance the crown, prevent failure of limbs or entire tree and maintain trees shape and form for future amenity value
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
