# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 shown on sketch plan is a mature Horse Chestnut adjacent to the boundary fence between the Old Coach House and the neighbouring New Rectory. Overall height is approx. 18m. The lower branches now extend to a depth of c. 4.5m into each property, although some branches have previously been shortened (when or by whom, not known) where they overhung into the New Rectory. When in full leaf in summer and especially when carrying conkers in autumn, the lower branches bow heavily towards the ground, the whole creating deep shade over both the planted border and halfway across the garden, making use of these areas for leisure and for hanging out washing very impractical. It is proposed to lift the crown of the tree to a height of 5m from ground level to remove 5 branches on the Old Coach House side and 5 (including dead and previously shortened branches) on the New Rectory side. This would create a well balanced and aesthetically pleasing structure, whilst allowing much needed light and usable space to the Old Coach House garden and eliminating the nuisance caused to its neighbouring property. This proposed work has been defined in conjunction with a qualified tree surgeon.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
