T1 and T2 Both mature sycamore trees in relativity close proximity to properties. For both trees we propose crown reducing over extended branches protruding from the canopy by 1-2 meters, by drop crotch pruning to suitable diameter regrowth. This will give a clearance from the properties and guttering of 3 meters and balancing in the rest of the canopy in other orientations. Crown clean by removing dead/ dying and crossing branches. Crown raise the canopy's and remove epicormic growth from trunks to give a clearance from the ground of 4 m. The objectives are to allow more light into the gardens, make the trees less encroaching and limit the growth towards properties without interfering with their form and future growth habits majorly.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
