To cut back predominantly Sycamore trees to boundary line of St Martins property, this is due to the encroachment of the ashes rose garden and no light to the rose plants on each grave. Also to protect from any possible damage to headstones in area.

To raise the crown approx 1 m up trunk of T2 Koelreuteria bipinnata (Golden Rain tree) to facilitate easier mowing of grass under tree and also for H & S reasons of low lying branches.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
