1 x Oak - Cutback all lateral aspects by 3m or back to boundary where growth point allow and remove all deadwood (+100mm) overhanging the rear garden of 5 Widmore Lodge Road.

Justification - To reduce the current canopy size and remove deadwood as nearby resident in concerned for safety of themselves and their children due to size of the visible deadwood and excessive leaf fall, due to current expansive size of existing canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
