The owner Mr Llyod Wallace at 8 Hallhead Road is in agreement with the removal of the Whitebeam tree as is very close to the wall and has outgrown its position causing excessive shade to the area of the neighbours garden at 10 Hallhead Road and his own. It has a codominant stem and the smaller stem of the two could fail/ break out with high winds. Mr Llyod will be re-planting a Rowan tree near the existing whitebeam to mitigate the loss.
