Works: Reduce/re-pollard to previous points to leave approx. 12.0m high by 12.0m spread and thereafter re-prune on a triennial cycle to maintain at broadly reduced dimensions.

Reason: Clay shrinkage subsidence damage at neighbouring property 69 Elmroyd Avenue, EN6 2EF.
