## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Our back garden sits 10m below a farmer's field which runs along the top of Back Lane. We are notifying intention to remove 10 trees at the top of the high bank at the back of our garden. As a result of Storm Babet rain flowed from the farmer's field at the top of the bank and caused a large tree to fall across the garden pulling down soil from the bank and smaller trees and vegetation. A civil engineer has planned remediation works which include construction of a 5m high stepped gabion retaining wall to secure the bank and prevent further collapse/erosion. Trees at the top of the bank are at risk of toppling as the soil around their roots has washed away and their roots have been exposed. We've been told by a tree surgeon and the engineer that the trees have been compromised, are unsafe and should be removed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
