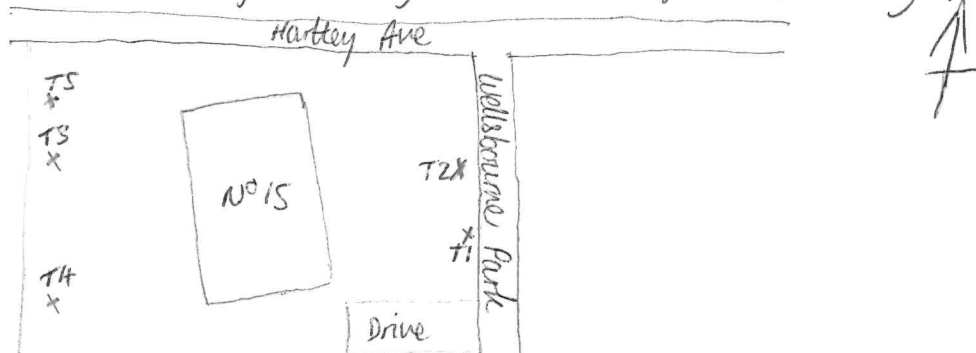

T3 - Oak. Reduce branches of lower section of crown growing towards property to give 3m clearance from property. Crown spread left at 4m. Causing excessive shading.

T4 - Holm Oak. Crown lift to 3m above ground level. Branches are touching property and causing excessive shading.

T5 - Laurel. Remove low, long extending branches over garden. Shading.
