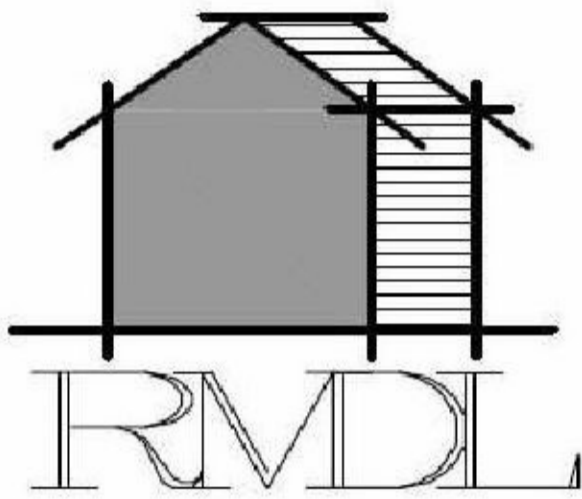
Good evening ,
