The proposed development involves the erection of a 'stretch tent' style marquee on the East side of the site more than 30m from the boundary with Old Wokingham Rd. The marquee will be situated over a refurbished outdoor climbing structure and used to provide shelter from the elements, allowing climbing to take place in wet weather and prolonging the life of the climbing structure. By providing shelter we will be improving access to leisure facilities for Bracknell Forest residents, making the outdoor climbing area a viable option for exercise all year round.

The marquee has been erected on a temporary basis (less than 28 days) to facilitate the works to the outdoor climbing structure. This application is for the long term retention of the marquee structure.

Amendments Summary

As stated in the original application the tent structure has been in place on a temporary basis to provide shelter for the renovation works to the outdoor boulder. Those works are now complete. The costs to remove and then re-instate the tent in the spring are prohibitively expensive, additionally this would also leave the refurbished structure exposed to the elements. As such we plan to keep the tent in place and have amended the application to be a retrospective application.
