Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Identification of the hedgerow can be seen in the google map view document. Cutting of the protected hedgerow is requested to enable sufficient access to the rear of the property to complete essential maintenance. Maintenance includes: Window work, roofing work, fascia, soffit and gutter work. The current limitation of room between the property and hedgerow prevents the work being completed. Work will only be completed along the red line on the google map view document and land registry.

With permission we would like to cut the hedgerow back to the centre of the hedge (being the stump) to allow adequate space and access in order to complete works on the rear of the property (see photo 8). By cutting back the hedgerow to the centre stump there would be a gain of up to 4ft meaning that the rear of the property can be accessed safely by ladders/scaffold for maintenance work (see access gain PDF).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
