Lime tree rear garden is now oversized and encroaching on to private property of 25 Harborough Way. Tree appears to have been heavily reduced some years previously. Recommend new growth to be reduced back to previous pollard points Secondary Pollard.

 - adding other relevant features on the site (e.g. greenhouse, paths)
