Based on the advice we have received from our tree surgeon, we wish to reduce the crowns in radius by approximately 3-5m (to previous cut lines).

The trees are healthy but are getting too big. They are in need of pruning to make sure they do not pose any risk to cars parked in the driveway or to people sitting in the garden.

The work will be carried out by Bruks Tree Surgery (Birchington), who carried out similar pruning work on the same trees in February 2020.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
