## Identification of Tree(s) and Description of Works

T30 Sycamore; To sectional fell the double stemmed Sycamore T30 on the boundary between Glen Lyon and Orchard House. The stem has a large amount of decaying fungi fruiting bodies at the base of the stem and at the junction between the two stems. The left stem as looking from Glen Lyon has a large amount of bark peel and there have been limbs of up to 6" diameter cracking out of the crown. As the tree's main lean angle and weight is toward Orchard House the homeowners are both concerned and anxious about the tree's structure failing and causing damage.

Proposal to replant with a Lime (Tilia) of approximately 150cm sourced from an appropriate tree nursery to be in keeping with established trees in the area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
