01- Oak

Remove poorly attached deadwood.

Reduce the crown spread from 10 m to no less than 7 m ensuring that all cuts are to an appropriate side branch no less than 1/3 the diameter of the parent branch.

The reason for this work is to contain the tree within the comparatively small domestic garden space.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- The number used on the sketch plan; and

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
