Works: Remove (fell) to near ground level and treat stump to inhibit regrowth.

Reason: Clay shrinkage subsidence damage at the property.

NOTES:

This S211 Notification has been submitted despite the diameter at chest height of the subject tree being recorded as <75mm - this is because the image of the tree in the MWA Arboricultural report shows a tree which may be considered worthy of submission.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
