T5 & T7 2 x Sycamore - Reduce crown 1.5m below previous pruning points leaving 2m

T6 Lime - Reduce crown 1.5m-2m to previous pruning points leaving 2-3m

T8 Horse chestnut - Reduce crown approx 1m below previous pruning points leaving 1.5-2m

T9 Lime - Reduce crown 1.5m below previous pruning points leaving 2m

T10 Lime - Reduce crown 1.5m below previous pruning points leaving 2m

T11 London plane - Reduce crown 2m below previous pruning points leaving 2m

T12 Horse chestnut - Reduce crown 1.5m below previous pruning points leaving 1.5m

T13 Lime - Reduce crown 1.5m below previous pruning points leaving 1.5m

T14 Horse chestnut - Reduce crown by approx 1m to previous pruning points leaving 3m

All above trees - To allow more light in to flats

T15 Lime - Reduce height by approx 5 to main crown break leaving approx 8-10m (decay at base/reduce risk of windthrow)

T16 Horse chestnut - Reduce crown by approx 2m leaving 3m

Allow more light

T17 Silver birch - Reduce crown by approx 2m leaving 2-3m

To retain crown size in car park area
