Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Beech tree at front of property- to fell.  The beech tree has a serve case of honey fungus. It is a 5 day notice application as it is in a very unsafe state. The bark is peeling off the front of the tree, it is unsafe and a dangerous tree that needs remove. Nick Conway WBC tree officer has been out to see the tree and spoken with the home owner and has said it needs to be removed urgently as the honey fungus is all over the base and on the tree. There are pictures to see. The tree has a server lean towards the property and if it fails it will damage the property very badly.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
