Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

There is a large ash tree growing directly on the boundary of our property (35 Benville Avenue) with Blaise Castle Estate, and this boundary constitutes the edge of the conservation area. As the land slopes steeply up from our property to the boundary and beyond, the garden is terraced and there is a retaining wall at the boundary. The ash tree has caused the retaining wall to collapse, and is now leaning at an angle of about 15 degrees directly downslope towards our property. The distance between the tree and our property is 20 metres, and the tree is tall enough to cause damage to the house if/when it falls. We are therefore very concerned about both the safety risk and the risk of damage to our house. We are relatively new to the property, but our neighbours have observed the lean of the tree steadily increasing over the last couple of years. The tree is also showing signs of ash die-back, with a thinning crown and a basal lesion.

Given the risk posed, and the fact that the tree is now almost entirely overhanging our property due to the lean, we need to have the tree professionally felled by a tree surgeon and we are therefore applying for permission to do so. We believe it is necessary to seek permission because, although our property is not within a conservation area, Blaise Castle Estate is in a conservation area and the tree is at least partially rooted within Blaise Castle Estate.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
