Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We need to fell the single pine tree in the front garden of 14 Butlers Mead, Blakeney. This is the only tree within the boundary. An application (PP 06836583) in 2018 has expired, we were unable to carry out the works within the timescale due to ill health. As before the reasons for felling this tree are: the proximity to main drains also in the front garden. The loss of light within the house meaning I have to have lights on during the day with would be avoided if the tree was removed. The branches from the now much larger tree overhang the road causing large vehicles to drive down the centre of the road to avoid it. Due to disability I am now unable to clear up the mess it causes in the road and prevent the drains from becoming blocked.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
