A001 - Cherry Laurel, Holly, Western Red Cedar, English Yew - Reduce in height to 5 metres above ground level and cut back to kerb line. Prune to clear street furniture by up to 1 metre.

A002, A003, A004, A006 - Cherry Laurel, Holly, Portugal Laurel, English Yew, Hazel, Field Maple, Norway Maple, Leyland Cypress, Elder - Reduce in height by up to 2 metres.

A005 - Sycamore, Leyland Cypress, Goat Willow, Cherry Laurel, Elm and Wild Cherry - Prune all round by up to 3 metres

G002 - Apple - Reduce all round by up to 0.5 metre to shape crown. Undertake formative pruning.

G004 - Norway Maple, Sycamore - Reduce southern aspect by up to 1.5 metres.

G006, G007, G008 - Leyland Cypress, Holly - Fell to ground level.

G009 - Lime - Crown lift up to 5 metres above ground level.

G010 - Crab Apple, Purple Cherry Plum - Fell to ground level.

G011 - English Yew, Holly, Cherry Laurel - Reduce all round by up to 1 metre.

H001 - Holly - Reduce in height down to 5 metres above ground level. Cut back sides by up to 0.5 metre.

H002 - Cherry Laurel - Reduce in height down to 4 metres above ground level. Cut back sides by up to 1 metre.

H003, H004, H005 - Cherry Laurel, Privet, Box, Holly, English Yew - Undertake annual hedge cut of up to 30cm.

H006 - English Yew - Reduce in height down to 2 metres above ground level.

H007 - Leyland Cypress, Cherry Laurel - Fell to ground level.

H008 - English Yew, Holly - Reduce in height down to 2 metres above ground level.

H009, H010 - Cherry Laurel - Reduce in height down to 2 metres above ground level and cut back sides by up to 1 metre.

T001 - Sycamore - Reduce in height down to 13 metres above ground level and reduce sides by up to 2 metres.

T002, T003 - Sycamore - Fell to ground level.

T006 - Western Red Cedar - Crown lift over summer house to provide up to 1.5 metres clearance.

T007 - Purple Cherry Plum - Fell to ground level.

T012, T013, T014, T019, T020, T021, T023, T024, T025, T034, T035 - Wild Cherry, Laburnum, Leyland Cypress, Lawson Cypress, Beech, Sycamore, Goat Willow - Fell to ground level.

T036 - English Yew - Reduce all round by up to 1 metre.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
