To install two gates, one either side of the property. The gates will consist of 40x10mm frame and centre rail: 16x16mm square spindles with 150mm rail heads on top. The gates will hang off a 50x50mm SHS post fixed to the brick wall. Each gate will be secured by a gate latch. The gate at No. 9 will open out due to the gas meter boxes. The gate at No. 10 will open inwards. All to be powder coated in black RAL 9005 to match railings as closely as possible.
