External changes to the proposal include the wall continuing instead of being inset as previously approved and adding a second roof light to the to the rear; this amendment does not create an overbearing impact to the neighboring property and benefits the structure of the proposal as two load-bearing walls will be on top of each other. The rear elevation consists of bi-fold doors that create 3 openings for the ground floor kitchen, living and dining. The Air source heat pump has been relocated to the right side of the development. Internal changes have been made to the kitchen and the location of the utility room, WC and plant room, as a result, to accommodate the internal changes fenestration positions have also been re-positioned accordingly. The first floor remains largely as previously approved with small internal amendments made to the master bedroom ensuite and the enlargement of the window. The internal layout of the loft remains largely as previously approved with small of the previously approved, the rear roof structure has been amended in this new proposal to accommodate a rear facing dormer compared to the previously approved roof lights.
