G1- Sycamore, Beech, Lime and Scots- varying stem diameters of 0.5-0.8m, varying canopy widths of- 3-6m, varying canopy height- 8-10m. This group of trees located at the bottom of the garden are beginning to reduce light into the garden substantially. requesting permission to reduce this group of trees height by 2m, allowing more light into the garden. (Excluding any Scots Pine)

This reduction will significantly increase the amount of light in the garden and improve the efficiency of the house solar PV panels located on the roof elevation facing the trees by reducing the shading, whilst maintaining the integrity of the trees. It will, in conjunction with the house solar battery system, result in a positive gain to the UK net zero carbon reduction target
