T1 is a European Ash (Fraxinus excelsior) situated in the rear garden of the property.		
We plan to reduce the crown by up to 2m, ensuring all pruning cuts are to suitable growth points whilst maintaining a balanced and aesthetically pleasing shape. This is in order to control the size and reduce shading on the garden.		

We will also cut back from the phone lines where necessary, taking care not to negatively affect the trees form.
