I wish to pollard both trees back to their previous pollard point which was done 3 years ago with the addition of cutting the branches marked in the photo, approx 6 feet, this is to remove the overgrowth on one side. This was approved by the tree officer after it's last cut but I decided to leave it until it needed pollarding again to do it all in one go.
