H - mixed hedge line on the boundary of Byrams in Sherwood Place and Crossmead in Birchetts Avenue. Reducing conifer by 3 metres and trim sides. Trim and tidy yew and reduce to match conifer. Trim holly and reduce viburnum to match conifer. Re-pollard cretagis.

This is all to provide a more unified and tidy hedge line.
