Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The Tree is located in the front garden of the property address given for this application and extends across boundaries to neighbour and encroaches onto adjacent public footpath. While the tree is not identified as protected, it is situated within a conservation area and we would like to full-fill our responsibility as the landowner to maintain the tree in question.

The proposal includes topping of the tree height below the gable peak of the property (See Sketch Document) of the property (circa 5-5.5m) and lopping of branches extending out and beyond aforementioned boundaries , providing adequate clearance on all perimeters. We do not intend on cutting the tree down fully at any point, rather control of growth only, in keeping with the look of the surrounding area.

The above will help to maintain a neat habit/ shape of the tree and reduce risk of falling branches onto the property and adjoining properties/ footpath.

Works would be re-occurring, as and when required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
