- T1 Scots Pine No Action
- T2 Holm Oak Tree Reduce by 35% overall, (approx 5m off height),
- T3 Sycamore Tree Reduce by 35% overall (height by approx. 4-5m)
- T5 Sycamore Tree Reduce by 35% overall, approx. 4-5m height reduction and 2-3m off sides
- T4 Ash Tree Reduce by 35% overall, approx. 5m off height, 2-3m off sides)

All works to control size of Trees for size of Garden and location, Trees causing shading issues to the property and the neighbours garden. Also causing TV reception problems for the same houses .

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
