Statement of work:

G1 Hornbeam - 2 neighbouring trees (located at number 10), 1 of which is in decline - To carefully section fell as close to ground level as possible the declining tree. To cut back overhanging laterals by up to 1.5 metres on the remaining healthy tree.

G2 Hornbeam - Group of 10 trees across the rear boundary: 2 trees closest to LHB, signs of extensive bark damage - To carefully section fell as close to ground level as possible. To reduce a selection of lateral branches extending over the garden by up to 1.5 metres on the remaining 8 trees.

G3 Lime - Front boundary by the garage, 2 neighbouring street trees: To cut back a selection of lower laterals extending over the garden back to boundary

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
