## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Fagus sylvatica Atropurpurea (Copper beech) (TPO tree 76/1623, Map number 98) located in the rear garden approx 5m from the property.

The tree in question is positioned at the top of the garden bank, the root system is causing extensive damage to the neighbouring property and potentially causing damage to the drain system of both properties (report to be undertaken)

Proposed works - To dismantle the tree in question to as close to ground level as practically possible. An above standard Copper Beech to replace, much further away from the property.

Fagus Sylvatica (European beech tree) located on the road side boundary in between 2 lime trees-

To reduce in height and lateral spread by approximately 1.5m and raise the lower crown to 5.5m over the public highway.

Tilia x europaea (common lime) x 2 located either side of the European beech tree on the road side boundary -

To reduce in height and lateral spread by approximately 1.5m and raise the lower crown to 5.5m over the public highway

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
