T24 of North Shields Tree Preservation Order 1981 (Lime tree) crown reduce by a maximum of 1.5 metres, crown thin by 10% and crown raise to 3.5 metres in order to rebalance tree. Tree was previously suppressed by a large sycamore tree which was removed in 2017 when permission was granted for its removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
