T1) Large Turkey Oak Tree: removed deadwood throughout the crown. Reduce radial spread over Hillside House driveway and garage by up to 2m radial spread. Remove lateral branch groinwg over the garage roof. Reduce radial spread of remaining corwn by up to 2m branch length.

Works are to maintain good health and vigor of the tree. To reduce crown size to prevent branches overhaning buildings, driveway and cables.

T2) Smaller Turkey Oak Tree growing nearer to the road. Sparse thin crown, small yellowing leaves. Remove primary stems. Tree maintenance works. To prevent branch extending over the road and removing risk of failure. Both trees are located at the front of The Retreat
