The mature ornamental cherry tree of approximately 8m, has a divided trunk at 1.5m, of which the trunk closest to the house is partially decaying at the union with the main trunk. Permission is sort to reduce the height and width of this section, and lightly thin the overal crown density to reduce the weight of the upper section of the tree (this is the advice of a registered tree surgeon).				
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
