Crown Thinning to 1 Pine Tree to reduce the density of the tree's crown by removing some of the branches which overhang the artificial grass/decking area by 20% which will help:

To improve the garden and the maintenance required

To improve the shape and load balance of the trees

To reduce the amount of dead wood that drops onto the garden/hits the back windows, especially in strong winds

To reduce the pine cones which are affecting the enjoyment of the garden

To reduce areas of serious fouling of the garden / artificial grass/decking area by bird droppings

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
