Details of the pre-application advice received

Pre-application was received on 11 April 2022 for the replacement dwelling and the advice sheet with the planning officers comments was returned on 26th September 2022. In summary the comments noted the following;

- The principle development as a residential development would be acceptable at the officer's level as it is a replacement dwelling scheme.

- The site is well screened by hedges and the replacement dwelling is unlikely to urbanise the frontage.

- The planning officer was cautious about having new development within the RPZ of a mature tree.

- The ancillary garage building should have consistent design with the main building and renovation works should be included in any forthcoming planning applications.
