Tree of Heaven (T1) - Mature specimen rooted in rear garden. Heavy and bushy regenerative growth from repeated reductions. Both our client and the neighbour are increasingly frustrated with the dominance of the tree both in terms of shading and the space it takes up and also the cost of repeatedly managing it. We have advised to remove it and to replant with a more suitable species for the property in a more central position further down the garden (possibly Walnut).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Fell to ground level and treat stump.
