Lime tree on the driveway entrance of Little Hillcroft. The homeowner would like to remove one limb (approx. 8" diameter at source) growing towards the house and leaning on the lines. when in full leaf the branch hangs low and applies pressure on the cables, it also sheds small sticks and dead branches in the wind and they have been known to hang on the cables as well. I have recommended that all branches interfering with the cables are cut back to source to prevent any future problems and the remaining lower crown of the tree should be lifted to match the height and reduce damaging the aesthetic of the tree. I don't feel that such work will affect the tree detrimentally as lime trees are known to be fast growing and repair damage quickly. I also believe this work will help prevent costly works to repair telephone and power cables in the future.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
