Erection of a single storey wooden shed measuring approx 2.42m width , 3.6m length, 2.27m height to the rear of the back garden. It will be insulated and soundproofed using soundproof rockwool and 15mm blue soundproof plasterboard ,plaster skimmed and painted. The shed will have 2 windows (1 on each side). The shed will have the door location on the front (2.42m side of it).

The shed will then be used as Dog grooming salon as a business working from home of which a change of use will be needed if required.

The business will operated by my partner. It will be fairly small scale with approx 3/5 dogs per day , working approx 8am -5pm monday to friday with some saturdays included when business picks up. sundays will always be closed.

There will be no other people working in the salon and no persons employed.

The business will run on one dog at a time, strict policy on all dogs will be on a leash at all times, no Dangerous dogs or Banned dogs.

Clients will drop off and pick up only, there is ample parking in the streets outside and the property has ample parking for 2 cars on the driveway also.

No public will be permitted inside the salon (only on specific cases).

The salon will be fully enclosed by 2m fences on all sides and covered by cctv.

There will be no external signage.

The salon will be located at the rear of the garden at furthest point away from the houses and will be fully soundproofed.
