Details of the pre-application advice received

- Where cameras and associated cabling are located in new locations and/or adjacent to significant internal architectural features, we would expect to see elevation drawings to fully demonstrate the impact of the new camera therefore your Appendix D – FHP General Arrangement Plan Drawings showing CCTV camera locations should be expanded to include elevation drawings.
- A clear understanding of which type of camera is proposed in each location with manufacturers specification, dimensions, information on types of mounts/brackets. A table cross referencing with the photographs and proposed elevation would be useful. This table should indicated if the location is for a replacement camera or a new camera.
- More information about the installation of the cabling would also help. Where there are instances of surface mounted cabling, this is a good opportunity to improve the visual impact, by removing surface mounted cables and or discreetly re-route cables behind furniture.
