This application is for the complete removal of 2 trees. I have submitted 3 photos and a plan of the surrounding properties with this application. You will see that there are 2 large conifer trees (Lawsons Cypress) approximately 3 metres from each other in the middle of the garden. I have circled the trees 1 and 2 in the photo 'Trees to be removed.' The nearest tree 1 is approximately 10 metres from our property at 15 The Back. The second tree is approximately 13 metres from our property. Both trees are very big conifers and if they were to fall in a storm in the direction of our property they could cause substantial damage/death. Recently the wind has been blowing strongly overnight and both trees can be heard creaking indicating the trees may be stressed which can make them more susceptible to damage in a storm. There is a concrete floor in our garage building in the garden which is also cracked caused by the tree roots coming through. I currently plan to extend 15 The Back and I am concerned that the trees roots will interfere with the footings of our proposed extension if the trees continue to grow any larger.

The 2 trees that we would like to completely cut down and remove are both 'Lawsons Cypress' which is a variety of conifer. The nearest is approximately 10 metres from our house.
