Existing old wooden/part brick render conservatory to rear of house (adjoining rear garden) to be replaced by a brick render kitchen extension. The proposed single storey extension will be slightly smaller footprint from existing conservatory (from adjoining neighbour garden aspect as indicated on supplied plans) and have a low ridged roof with tiling to match existing roof. It is proposed to insulate the 1st floor exterior aspect of existing main house (not immediately bath road facing and not neighbour garden facing) with oak finish cladding - as indicated on the supplied plans. New location of main house door (moved from conservatory to side of main house (moving approx 1.5 M to right of house wall/adjoining existing kitchen window)
