T1- red oak in rear garden. Large with multi stem crown.

Work requesting to be carried out.

- remove major dead wood.

There is a large amount of dead wood thought out crown. With some major large limbs which are dead. Some of which are approximately over 30 foot long with the diameter of approximately 18 inches wide.

Customer has fear that the large limbs my fail in the near future.

- Remove one limb over garden.

Low long lateral limb encroaching garden.

Requesting to remove branch as customer has fear it will fail in near future and low canopy is encroaching on boundary hedge.

- Reduce limbs over neighbours garden by approximately 30% (left side) approximately 2-3 meters.

Requesting reduction on this section to reduce weight in long lateral limb with is growing over neighbours garden to prevent future limb failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
