 Tree type - Ash (*Fraxinus excelsior*) sapling
 Approx Height - 5m
 Approx Spread - 1.5m
 Location -Front garden Right hand boundary
 Service - Fell and treat
 Work required - Fell as close to trees current ground level as possible and leave the stump in the ground, Treat stump with one application of glyphosate (eco-plugs) only to best endeavour the prevention of regrowth.
 Reason - The removal of the tree is undertaken as a preventative measure to mitigate potential future damage to the retaining wall.
 Priority code - ON

Tree number - G1 & G2
 Tree type - multi-stem Ash (*Fraxinus excelsior*)
 Approx Height - 8-9m
 Approx Spread - 6-8m
 Location -Front garden Front boundary either side of path
 Service - Fell and treat
 Work required - Fell as close to trees current ground level as possible and leave the stump in the ground, Treat stump with one application of glyphosate (eco-plugs) only to best endeavour the prevention of regrowth.
 Reason - The removal of the tree is undertaken to prevent further damage to the retaining wall, as it has been identified as a contributing factor.
 Priority code - A

Tree number - T2
 Tree type - Sycamore (*Acer pseudoplatanus*) sapling
 Approx Height - 1.5m
 Approx Spread - 1m
 Location -Front garden left hand side (adjacent to G2)
 Service - Fell and treat
 Work required - Fell as close to trees current ground level as possible and leave the stump in the ground, Treat stump with one application of glyphosate (eco-plugs) only to best endeavour the prevention of regrowth.
 Reason - The removal of the tree is undertaken as a preventative measure to mitigate potential future damage to the retaining wall.
 Priority code - ON

Approx Height - 2m

Approx Spread - 1.5m

Location -Front garden left hand boundary

Service - Fell and treat

Work required - Fell as close to trees current ground level as possible and leave the stump in the ground, Treat stump with one application of glyphosate (eco-plugs) only to best endeavour the prevention of regrowth.

Reason - The removal of the tree is undertaken as a preventative measure to mitigate potential future damage to the retaining wall.

Priority code - ON

Tree number - G3 & T4

Tree type - multi-stem Sycamore (Acer psuedoplatanus)

Approx Height - 12m

Approx Spread - 8m

Location -rear carpark area at rear of property

Service - Fell and treat

Work required - Fell as close to trees current ground level as possible and leave the stump in the ground, Treat stump with one application of glyphosate (eco-plugs) only to best endeavour the prevention of regrowth.

Reason - As per clients instructions

Priority code - ON - Not going ahead with these works

PN - client to ensure the entire carpark area at the rear is completely clear of vehicles if Artemis are to undertake G3 and T4, if the only trees in the front garden (T1, T2, T3, G1 & G2) are being carried out then client only need to reserve space in carpark area for our work vehicles and machinery (approximately 5 parking bays).

All resulting brushwood and logs will be transported to our recycling depot awaiting transfer to Thetford Power Station to be used as bio-fuel **(unless otherwise stated in work description above).**
