1 Larch: Crown Lift to provide 5 metres clearance from ground level reduce lateral growth over the batting nets by 3 metres

2 Rear hedges / trees: Remove all piles of debris from the hedge row. Fell/remove any dangerous trees. Trim/prune remaining growth to leave a neater appearance

3 Rear of football pitch: Crown Lift trees to provide 4 metres clearance from ground level. Trim/prune lower growth to provide a neater appearance

Reason for works:

1 - Larch - currently interfering with the batting nets, being reduced/raised to allow clearance.

2 – Mixed trees/shrubs – area has become over grown with various dead stems and trees, anything dangerous is to be removed and the remaining is to be neatened to improve the amenity of the area.

3 - Mostly Lime - being raised to prevent interference with the adjacent football pitch.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
